

Quarterly Report

January - March 2018

There is some good news to share with all of you. In a big relief to the hospitals working in the community, the government has finally increased the Grant In Aid for cataract surgery to Rs 2000. SPOs have been advised to consider increased grant-in-aid (GIA) while preparing PIPs for FY 2018-19.

We had made a representation for an increase in GIA to the ministry and had been persistently advocating it with relevant ministry officials from the DDG (O), NPCB, Deputy Secretary and Economic Advisor at health ministry. The new rates are likely to come into effect from April 2018.

We have also submitted a representation to the ministry of finance and Goods and Service Tax Council office seeking rationalization of GST rates on Intra Ocular Lenses. The Industry associations have also submitted a separate letter seeking a relief in GST rates. Mr Govind Hari, Secretary on VISION 2020 INDIA board has been representing our case in the GST meetings and the discussions do point toward a positive outcome.

The 14th annual conference 'Advocacy & Inclusive Partnership for Eye Health' is little more than a month away on 9 & 10 June 2018 at Sri Sankaradeva Netralaya, Guwahati. The scientific committee for conference has designed a stimulating programme that aims to debate and discuss some very topical issues in community eye health. The conference will also provide a platform for our members to share their experiences and share knowledge. Please do avail of this excellent opportunity.

Advocacy

During a meeting with Dr Promila Gupta, DDG (O), NPCB, she gave following updates:

- Revised Grant-in-aid will come into effect from April 2018
- Revised HMIS will be implemented soon. Some of the new features likely to be included:

There exists good possibility to reimburse the GIA directly to NGOs' account from Centre or State level. 10% data verification is likely to be automatic – 5% on SMS based and 5% IVR based.

DPM will have only 10 days for further review of data, after which is considered deemed approved.


